The ESG specialist intern will sit in the Responsible Development team and support the four team members on a diverse range of tasks.

General Overview of Responsibilities:

This internship is an opportunity to dive into sustainable finance topics and gain extensive knowledge on the latest ESG regulations, responsible investment strategies as well as specific sustainability themes such as climate change, biodiversity and human rights.

The ESG specialist intern will work closely with Comgest's various teams (investment teams, risk management and compliance teams, investor relations and client services teams, etc.) and focus on the following tasks:

- Assist on client ESG reporting and communications
- Support ESG regulatory implementation and reporting
- Use ESG data, tools, and databases (both internal and external) to produce ESG analytics and reports
- Participate in project managing collaborative engagement campaigns
- Create thematic content on topics such as climate change, biodiversity or human rights
